

Further, the revised dates of CBT scheduled is as under:


Date	Shift	Candidates attending CBT

23.12.2023 (Saturday)	1 st Shift	Candidates of Junior Engineer

Notice in this regard has been published in the RRC website for information of all the eligible candidates and advised to be ready for the Computer Based Test which will be held as per the above tentative schedule.

In this connection, all **controlling officers are requested to note the revised dates and accordingly employees may be relieved in time, as per the scheduled date(s) of CBT duly issuing duty passes to all the employees attending CBT and make suitable arrangement for travel if normal train service is not available at places with large concentration of candidates at respective Units/divisions. In this regard a formal request for necessary arrangement may be given to CPTM/SCR/SC.**
