FOR CANDIDATES SHORTLISTED FOR PETCEN No. RRC-08/2024 (Level-I posts)

All the shortlisted candidates for PET are advised as follows:

1. The candidates will be allowed to appear for PET only on producing the printed E-Call Letter on their prescribed date & Time only. E-Call Letters containing the PET date, time, venue and detailed instructions will be available on the official RRB/RRC websites in due course. Requests for change of PET venue, date or time will not be entertained under any circumstances.
2. In terms of Rule 5 of the Aadhaar authentication for Good Governance (Social Welfare, Innovation, knowledge) Rules, 2020 read with Section 4(4)(b)(ii) of the Aadhaar Act, 2016(as amended), the Railway Recruitment Boards are allowed to perform Aadhaar Authentication, on voluntary basis, for establishing identity of each candidate to avoid impersonation and other malpractices during the examination and to ensure fair conduct of examination. Accordingly, Aadhaar based Biometric Authentication of Candidates will be carried out before Physical Efficiency Test (PET). Candidates are therefore advised to unlock their E-Aadhaar, if secured, before reporting and must bring their **Original Aadhaar Card** for verification. The candidates must bring their any one of the other original documents i.e. **Pan card, Voter Id, Passport, Driving license** in case Aadhaar authentication is unsuccessful.(Soft copy of ID proof will not be accepted).
3. In the PET, candidates will first undergo the weight-carrying test i.e 100 meter (Event-I). Only those who qualify in this event will be permitted to take the 2nd Event of running test i.e 1000 meter). Candidates failing the weight-carrying test will not be allowed to participate in the running test(Event-II).
4. No changing room facility will be provided for male or female candidates at the PET venue. Candidates are advised to wear comfortable shoes to ensure their personal safety and minimize the risk of injury during the PET. They are also advised to avoid bringing luggage/bags, mobile phones, electronic gadgets/watches, or valuables at PET venue. No safe-custody facility will be available at the venue. RRC/SCR will not be responsible for any loss or misplacement of such items.
5. Candidates are advised to be prepared to stay for additional day(s), if required.
6. The candidature of shortlisted candidates for PET is purely provisional and may be cancelled at any stage for any discrepancy, deficiency, or malpractice. Mere participation in the PET does not confer any right to appointment in the Railway.
7. While every care has been taken in preparing the list of candidates shortlisted for PET, RRB/RRC reserve the right to rectify any inadvertent or typographical/printing mistakes. RRB/RRC regrets inability to entertain any correspondence from non-shortlisted candidates.
8. Beware of touts/agents promising Railway jobs through unfair means. RRB/RRC does not appoint agents or coaching centers. Selection is purely on merit, and attempts to influence the process may lead to disqualification and legal action. Candidates are advised to visit only the official website of RRBs/RRCs and beware of FAKE websites and social media content put up by unscrupulous elements/touts.
