NOTICE

INTIMATION REGARDING MEDICAL EXAMINATION &
SUBMISSION OF APPEAL AGAINST MEDICAL EXAMINATION

CEN No. RRC-01/2019 (Level -1 posts of 7th CPC Pay Matrix)

On qualifying Computer Based Test (CBT) and Physical Efficiency Test (PET) conducted by Railway Recruitment Board/Cell, Secunderabad, the following candidates as per the list enclosed as Annexure-A were called for document verification and medical examination for Level-1 posts notified vide employment notification mentioned above. They have attended the medical examination and the medical authorities have declared these 123 (One hundred and twenty three) candidates fit in B2 & below. An E-mail to the registered mail IDs will be sent to the candidates for information regarding appeal.

Ordinarily there is no right to appeal against the finding of an examining medical authority as per Para No. 522 (1)(i) of IRMM-2000. In case if you feel that there is any possibility of error of judgment in the decision of the examining medical authority, you may appeal through the recruitment authority subject to satisfactory compliance of the following criteria:

1. These candidate should appeal (Annexure-B) to the recruitment authority i.e. RRC/SCR/SC within one month from the date of communication. **You may send your appeal to the Recruitment authority by Registered post only along with Demand Draft for Rs.1000/- in favour of FA&CAO/SCR/SC as medical examination expenses.**
2. The candidates have to attach the medical certificate issued by Medical Practitioner in support of their evidence about the possibility of error of judgment in the decision of the Railway medical authority. The copy of the medical certificate format is enclosed herewith as Annexure-C.
3. The appeal received will be forwarded to Chief Medical Director, South Central Railway, Secunderabad for administrative approval. If the candidate's appeal got approved, they will be given a fresh date for re-medical examination. If the candidate fails to attend on fixed date his/her candidature will be cancelled.
4. If the result of the re-medical examination differs and they are found fit for the better medical classification i.e. **B-1 and above**, the medical expenses collected in the form of DD will be returned back.

The appeal along with medical certificate as enclosed format should reach to Senior Personnel Officer, Railway Recruitment Cell, 1st floor, C-Block, Railnilayam, Secunderabad-500 025 Telangana on or before **13.05.2023**.

If the candidate fails to make an appeal on or before **13.05.2023**, it will be presumed that he/she is satisfied with the medical examination report given by Railway Medical Authorities and the candidature will be cancelled without giving any further opportunity.

MEDICAL STANDARDS FOR THE POSTS

Candidates called for DV will have to pass requisite medical fitness test(s) conducted by the Railway Administration to ensure that the candidates are medically fit to carry out the duties connected with the post(s) opted by them. Visual Acuity Standard is one of the important criteria of medical fitness of railway staff. The following medical requirements against different medical standards for different categories, notified vide **CEN No. RRC-01/2019**, are outlined below:

S.No.	MEDICAL STANDARD	GENERAL FITNESS	VISUAL ACUITY
1	A-2	Physically fit in all respects	<u>Distant Vision:</u> 6/9, 6/9 without glasses(no fogging test) <u>Near Vision:</u> Sn. 0.6, 0.6 without glasses and Must pass tests for Colour Vision, Binocular Vision, Night Vision, Mesopic vision etc.
2	A-3	Physically fit in all respects	<u>Distant Vision:</u> 6/9, 6/9 with or without glasses (power of lenses not to exceed 2D). <u>Near Vision:</u> Sn: 0.6, 0.6 with or without glasses and Must pass test for Colour Vision, Binocular Vision, Night Vision, Myopic vision etc.
3	B-1	Physically fit in all respects	<u>Distant Vision:</u> 6/9, 6/12 with or without glasses (power of lenses not to exceed 4D), <u>Near Vision:</u> Sn. 0.6, 0.6 with or without glasses when reading or close work is required and Must pass test for Colour Vision, Binocular Vision, Night Vision, Mesopic vision etc.

Note: The above medical standards are indicative and not exhaustive and apply to candidates in general. The candidates are advised to read Chapter 5 of Indian Railway Medical Manual Vol.I, which can be accessed at www.indianrailways.gov.in. Candidates who have undergone Lasik surgery or any other surgery procedure to correct refractory error are not eligible for the post having Medical Standards A2, A3 and B1.
